may be reached are:

- Students will be held accountable for the behavior of their guest.
- No reimbursement or refund will be given if a student and/or guest are asked to leave for not following the agreement.
- All attendees must be willing to submit to alcohol testing.
- All students and their guest may be searched for weapons and illegal substances prior to entry of the Prom.
- All students and guests must be picked up **NO LATER THAN 11:15 P.M.**
- Students who violate any school rule or terms of this contract will face disciplinary action.
