- 1. During the month of August, the rate of interest on investments was 0.18% for Fund A of the State Board of Administration, 0.02% for the Wells Fargo Investment Account and .04% for the Dreyfus Fund.
- 2. For comparison purposes with the General Fund Statement of Revenue, we have completed 16.67% of the fiscal year. All other percentages are only a comparison of cash collections or expenditures to budgeted revenue or appropriations.
- 3. Negative cash balance and investment amounts are due to timing of cash requests.
- 4. Cash balance in Debt Service Fund held by Bank of America represents cash held by fiscal agent for QZAB sinking fund.
- 5. SBA Fund A consists of high quality money market assets. Nassau County School Board can redeem the full amount.
- 6. SBA Fund B includes assets having significant credit or liquidity risk or assets considered in default. Fund B is shown in General Fund and the Capital Projects Fund. At this time, Nassau County School Board cannot redeem these funds, but distributons to SBA Fund A are made periodically. Net decrease in fair value of investments totaling \$107,115.38 have been reported on prior Annual Financial Reports.
