## **FIELD MOWING OF SCHOOL GROUNDS**

**BID # 2010-03**

**DATE DUE: May 13, 2010, 2:00 P.M.**

The School Board of Nassau County is requesting sealed bids for the furnishing of all equipment, labor and insurance to mow school grounds at various Nassau County Schools. The successful bidder agrees to enter into a contract to provide these services for the months of July, August, and September 2010 and April, May, June 2011. This bid may be extended for two (2) additional twelve (12) month periods by approval of the successful bidder and The Nassau County School District.

1. There will be a pre-bid conference and inspection of the school sites on May 3, 2010 beginning at 8:00 a.m. and only those bidders who accompany Mr. Jeff Whittemore on the pre-bid conference and inspection will be eligible to bid on this project. Prospective bidders shall meet at the Nassau County School District Maintenance Facility, located at 86334 Goodbread Drive, Yulee, Florida.
2. Mowing will be done during the months of July, August, and September 2010 and April, May, June 2011. Each location shall be mowed every other week. Mr. Tim Groat may request additional mowing at the bid amount for a school or area.
3. Proof of Liability and Worker's Compensation Insurance is required with minimums of \$100,000/\$300,000 for Liability and State Requirements for Worker's Compensation. Certificates of insurance will need to be provided at the commencement of work prior to July 1, 2010. **THE NASSAU COUNTY SCHOOL DISTRICT SHALL BE LISTED AS ADDITIONAL NAMED INSURED ON THE CERTIFICATE OF INSURANCE.**
4. The schedules for mowing will be agreed to, in advance, by the various Principals and Mr. Groat, prior to any work being done. Schedules may not be changed without Mr. Groat approving the changes. The successful bidder may be permitted to mow on weekends and holidays after discussion and agreement with Mr. Groat.
5. **THERE WILL BE NO MOWING WHEN THE STUDENTS ARE IN OR ADJACENT THE MOWING AREA.** There will be no exceptions to this requirement. Failure to follow this requirement may result in termination of the contract.

6. Football fields, Softball fields and Baseball fields are not included in this bid. School personnel will maintain these fields. This includes only the areas within the fences of the athletic fields. All areas outside of the track are included in this bid. Only the playing field is excluded.
7. Any damages to School Board property, as a result of the mowing operation, shall be reported immediately to Mr. Groat. Any damaged property noticed during the pre-bid conference and inspection on May 3, 2010 shall be brought to the attention of Mr. Whittemore.
8. Mowing equipment shall be maintained in a condition, which will provide a clean cut, will not tear the grass, and will not cause injury to Students and Employees or damage School Property. Mowers pulled behind tractors are acceptable as long as they are finish type mowers or high speed blade tip mowers. Bush hog, brush type mowers are not acceptable.
9. Grass shall be cut no closer than three inches (3") or higher than four and one half inches ( 4-1/2").
10. Grass shall be cut as close as possible to fences, pavement, sidewalks, curbs, trees, shrubs, playground equipment and structures. Trimming shall be provided around the above one time per month. Trimming shall not include the use of herbicides, ie. Weed killer.
11. Grass in ditches, waste water treatment plants and retention ponds shall be cut with mowers or trimmers, as required, one time per month to the water's edge.
12. The prospective bidders may bid on one, two or all four areas. The bid will be awarded to the lowest best bid for each area.
13. The successful bidder must meet the requirements of Section 1012.32, Florida Statutes, commonly referred to as the Jessica Lunsford Act.
