

## McKinney-Vento Program/MVP Interview Response Sheet

- McKinney-Vento students must be enrolled in school immediately. MVP (McKinney-Vento Program) students have 30 school days to obtain required documents normally needed for school enrollment.
- Affidavit of Residency (school's form): mark "homeless" in bottom right corner. Residency proof cannot be required for enrollment of homeless students.
- Provide copy of "MVP Topics" sheet and Food Support list to all families.

☐ MVP enrollment is for one school year. Re-enrollment the following year is based on continued eligibility. Contact your child's school or the MVP Liaison for re-enrollment after July 1<sup>st</sup>.
