I. Call to Order Stephanie Lunt, Chair

Chair Lunt called the meeting to order at 6:00 PM.

II. Review and accept minutes from February 1, 2024, meeting S. Lunt

Chair Lunt gave all members a copy of the February 1, 2024, Millage Referendum Citizens Oversight Committee Meeting minutes. Chair Lunt provided all members with time to read and review the minutes. Chair Lunt asked for any updates, changes, or revisions to the minutes. Hearing none, Chair Lunt requested a motion to approve the minutes as presented. Elizabeth "Betty" Benton gave the first motion, followed by a second motion provided by Rachel Kerestes. Chair Lunt called for a vote, and all members voted to approve the minutes as presented.

Mr. Durham shared the Millage Request Form and process, which was created for principals to apply to spend the millage funds for which they are allocated. Then, all workgroup chairs presented an update to the committee on progress in each area. Mr. Hodges gave a presentation that included millage calculations for salary supplements, millage employee group breakdown of gross wages and benefits total per employee group, and salary expenditures as of April 11, 2024. Mr. Schmelling and Mr. Raysor discussed specific progress on their approved plans. Ms. Drake reviewed the specific Millage Request Forms from the principals who had submitted their applications and the decisions made on each request by the District Budget Committee.

IV. Financial Update

The report included crucial details such as the Project, Revenue 2023-24 Revised Budget, Revenue 2023-24 Fiscal Year to Date Activity, and Expenditures, which encompassed purchase orders already created and approved. ## IX. Comments from Committee Members and Staff

Comments gathered from committee members and staff included:

- \*A problem-solving discussion was held around transportation concerns for athletics, with some schools reporting that parents had to drive their children to various athletic events.
- \*A request was made for the Nassau County School District to develop and provide to the Millage Oversight Committee a system of accounting that will show the total amount of funds spent per discipline at each school. For example, how much of the millage funds were spent on the band, chorus, football, baseball, or softball?
- \*A request was made for the Nassau County School District to update the Millage Request Form to include additional data metrics such as number of students impacted and cost per student to correlate the data metrics to items such as pass rates, engagements, and enrollment.
