Chicken bowl @ 124 vice hot held @ 135. Informed staff who placed it back in the warmer. Talked with staff about the age of the heating elements and to inform her supervisors if they are struggling to maintain temperature.

CODE REFERENCE: 64E-11.003(2). PHF/TCS foods, which are held hot and not subject to an approved HACCP plan, must be maintained at 135°F.

General Comments

All handwashing stations equipped with hot water greater than 100 degrees Fahrenheit. Sanitizer @ 200 ppm. Hamburgers @ 147, fruit cocktail @ 39, chicken bowls @ 124 - COS, broccoli @ 147, hamburger @ 137, chicken bowl @ 138. Work orders in for the lights that are out.
