All temperatures in Fahrenheit. All handwashing sinks equipped with hot water greater than 100 degrees. Chicken taco @ 163, corn @ 190, cucumbers @ 41, pineapple @ 39, hot dog @ 187, chicken @ 164. Lights are out over the serving line. Work order has been placed and needs to be rectified asap. Lights in serving line itself are in working order. Sanitizer @ 400ppm.
